- 1 party asks for a stronger EU ethics authority and strong EU-level legislation on lobbying.

#### The prominence of the rule of law in the manifesto – Summary:

The rule of law features prominently, with "Defend the rule of law and slash corruption" as a key priority, and extensive manifesto elements addressing the rule of law

### Overall rule of law concerns

- \* Commitment to the use of Art. 7 of the Treaty on European Union (TEU)
- \* Expanding the rule of law report and the rule of law mechanism
- \* Multiple mentions of the use of financial tools, such as the rule of law conditionality, to enforce EU values

## **Independence** of the Judiciary

\* Pledge to uphold the integrity of institutions and fight against the erosion of the independence of the judiciary

#### **Anti-Corruption**

- \* Commitment to establish an effective anti-corruption sanction regime in Europe and reinforce national anti-corruption agencies with more funding
- \* Vow to secure the functioning of the European Anti-Fraud Office (OLAF), by ensuring national cooperation and adherence to recommendations
- \* Call to fostering an improved civil service with anti-corruption policies (including policy monitoring)

#### **Media Freedom**

- \* Commitment to creating a
  European watchdog to protect
  and promote media freedom and
  independence across Europe
- \* Promise to initiate a European fund for independent media, aimed at helping media against strategic lawsuits against public participation (SLAPPs)

## **European Green Party**(**Greens**)

#### The prominence of the rule of law in the manifesto – Summary:

The rule of law features prominently, with "Taking rapid action for democracy and the rule of law", "Fighting corruption! Politics need to be transparent and accountable", and "Free and independent media for Europe" as sub-prioritie

### Overall rule of law concerns

- Mention of the importance of the Art. 7 TEU procedure
- \* Commitment to the introduction of a Fundamental Values Annual Review to "monitor, enforce, and sanction the infringement"
- \* Commitment to supporting
  EU candidate countries in
  strengthening the rule of law

## **Independence** of the Judiciary

\* General commitment to stand for judicial independence

### **Anti-Corruption**

- \* Call for a stronger EU ethics authority and strong EU-level legislation on lobbying
- Call for more transparency of EU institutions, including Member
   State positions in the Council
- \* Vow to have members and senior staff of EU institutions declare their assets
- \* Support for OLAF and the European Public Prosecutor's Office (EPPO)

#### **Media Freedom**

- \* Call for an EU framework to protect journalists and prevent media concentration
- \* Vow to monitor the application of EU laws pertaining to media and implementation of the European Media Freedom Act and the anti-SLAPP directive
- \* Undertaking to support pan-European media and reporting on European affairs



## European Democratic Party (EDP)

#### The prominence of the rule of law in the manifesto – Summary:

The rule of law features in the manifesto, with a particular focus on the situation of media and journalists in the priority "Media and pluralism"

### Overall rule of law concerns

- \* Commitment to strengthening civil society and local authorities when sanctioning Member States for breaches of the rule of law
- \* Commitment to protecting the rule of law in the EU's neighbourhood

## Independence of the Judiciary

\* No mention

#### **Anti-Corruption**

\* General commitment to fighting corruption

#### **Media Freedom**

- \* Commitment to protect journalists from both threats and workplace insecurity, and to guard the independence of public media
- \* Undertaking to promote media freedom and diversity, and to avoid excessive concentration and monopolies
- \* Commitment to boost civic education and media skills, including the ability to understand issues related to the media
- \* Vow to encourage digitisation of newspapers and broader coverage of European issues, and to promote European and cross-border media

## European People's Party (EPP)

#### The prominence of the rule of law in the manifesto – Summary:

The rule of law is mentioned in the manifesto preamble and features prominently in the sub-priority "Our Europe preserve our democracy, traditions, cultural richness, and diversity"

### Overall rule of law concerns

- Mention of the failure of the Art. 7TEU procedure
- \* Commitment to the rule of law conditionality mechanism
- \* Support for rule of law financial conditionality mechanism
- \* Commitment to fair, non-partisan application of the rule of law mechanism, and to ensuring its adequacy and effectiveness

## Independence of the Judiciary

\* No mention

#### **Anti-Corruption**

\* Fighting against corruption is mentioned in the context of protecting the economy

#### **Media Freedom**

\* Commitment to working with journalists' organisations to strengthen fact-checking

## The Party of European Socialists (PES)

The rule of law features prominently, with the dedicated sub-priority "Defend democracy and the rule of law"

### Overall rule of law concerns

- \* Commitment to defending the rule of law at all levels
- \* Condemnation of conservative and liberal parties for enabling the far right
- \* Call for clear rules and sanctions to prevent EU funding from reaching autocratic governments

## Independence of the Judiciary

\* General mention of a trustworthy justice system as a means of defending the rule of law

#### **Anti-Corruption**

\* General mention of anticorruption measures as a means of defending the rule of law

#### **Media Freedom**

\* General mention of media freedom and pluralism as means of defending the rule of law



## European Christian Political Movement (ECPM)

The rule of law is not a priority item in the manifesto

### Overall rule of law concerns

- \* Mention of the rule of law as a value to be protected in EU economic policies
- \* Rule of law concerns highlighted as the reasoning behind ECPM's opposition to Turkey's EU Membership

## Independence of the Judiciary

\* No mention

#### **Anti-Corruption**

\* Incidental mentions of corruption as an impediment to economic development

#### **Media Freedom**

\* No significant mention of media or priorities for their protection/ strengthening
